1.1.2: The institution adheres to the academic calendar including for the conduct of CIE

The Institution prepares and publishes an 'Academic Calendar' containing the relevant information regarding the teaching-learning schedule (working days), various events to be organized, holidays, dates of internal examination, semester examination, etc. The student's academic progress is monitored regularly by adopting the strategy of continuous internal evaluation, seminars, project work, unit tests, and semester examinations. The examination committee sends the information to the University about the students who are appearing for the examination. After receiving the enrolled list of the students from the University, the college prepares a seating arrangement chart, a list of invigilators, etc. The record of internal assessment is maintained at the college level. Every department has to submit the compliance of the academic calendar as part of their annual submissions. The process is as follows:

1. Lecture schedule

The timetable coordinator prepares the timetable as per the guidelines of Mumbai University for the number of credit hours for each subject and the academic calendar prior to the start of the semester. The timetable is displayed on the notice board for each year.

2. Teacher: Every teacher is assigned the subjects to be taught during the academic year. The teacher plans the teaching and evaluation schedule of the assigned subject. The type and schedule of internal evaluation is Planned in consultation with the head of the department. Head of the Department: The Head of the department compiles the academic plan submitted by the teachers and ensures that there is no overlapping of the activities in general and the Continuous Internal Evaluation in particular at both the internal as well as the University level Then the Academic Calendar is forwarded to the IQAC.

3. Assignment and quiz

In addition to the test, assignments are also part of continuous internal evaluation. Assignments are provided to students on the scheduled dates mentioned in the academic calendar. Every teacher conducts the regular class test on the related topic.

4. IQAC: The IQAC compiles the inputs received from the various departments and a comprehensive plan is prepared and uploaded on the college website.

5. Stakeholders: The stakeholders are aware of the Continuous Internal Evaluation of every department in the college.

The academic calendar also includes the dates of midterm, final submissions, and the date for commencement of Practical/Oral exams. The midterm/final submission dates enable the students to be ready with their course/lab manuals/files to aid in CIE and timely & efficient submissions. The Academic Calendar is then approved by the members of the Academic Council and circulated by the Principal to all the departments. The same is also attached to the faculty handbook and is strictly adhered to. Any change in the calendar during the semester, owing to any unforeseen circumstances, is approved by the Principal and communicated to all the faculty members.

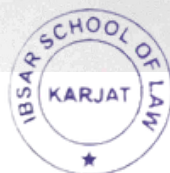
