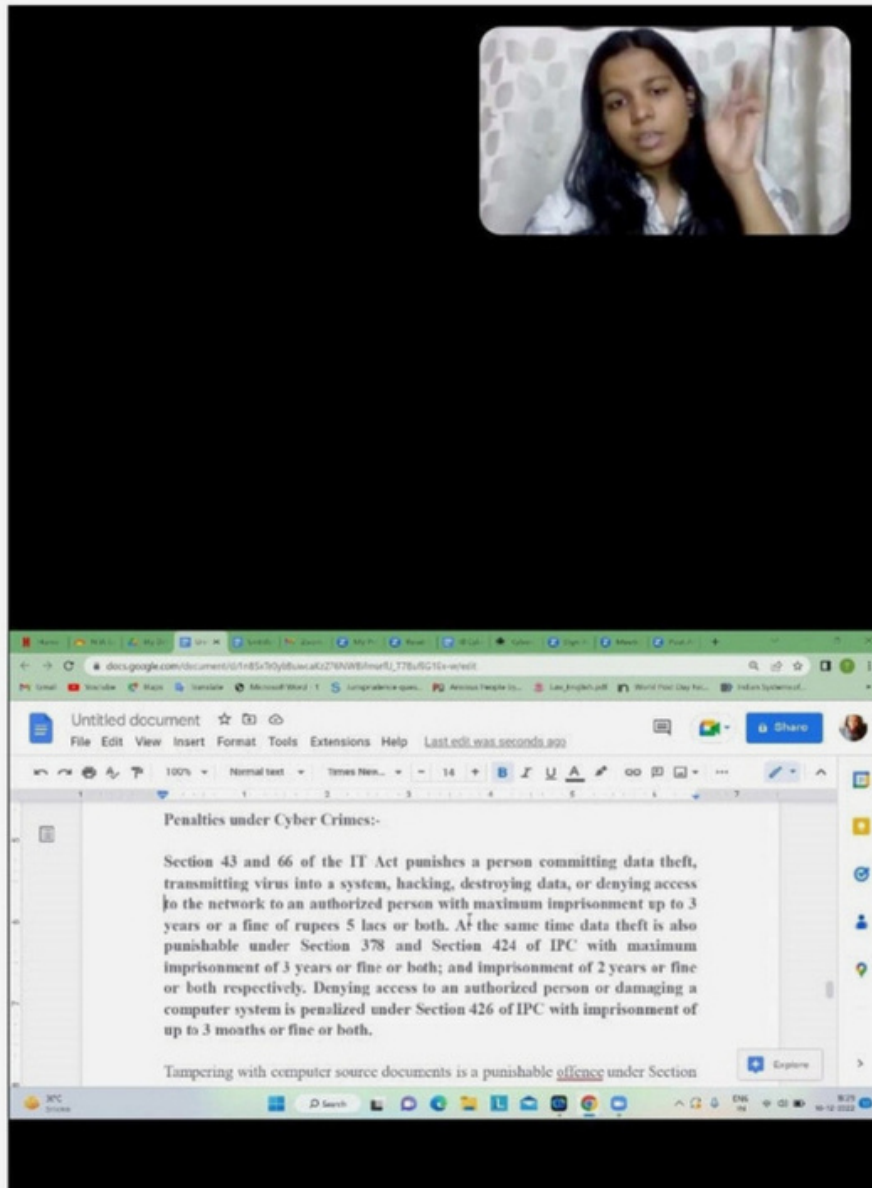

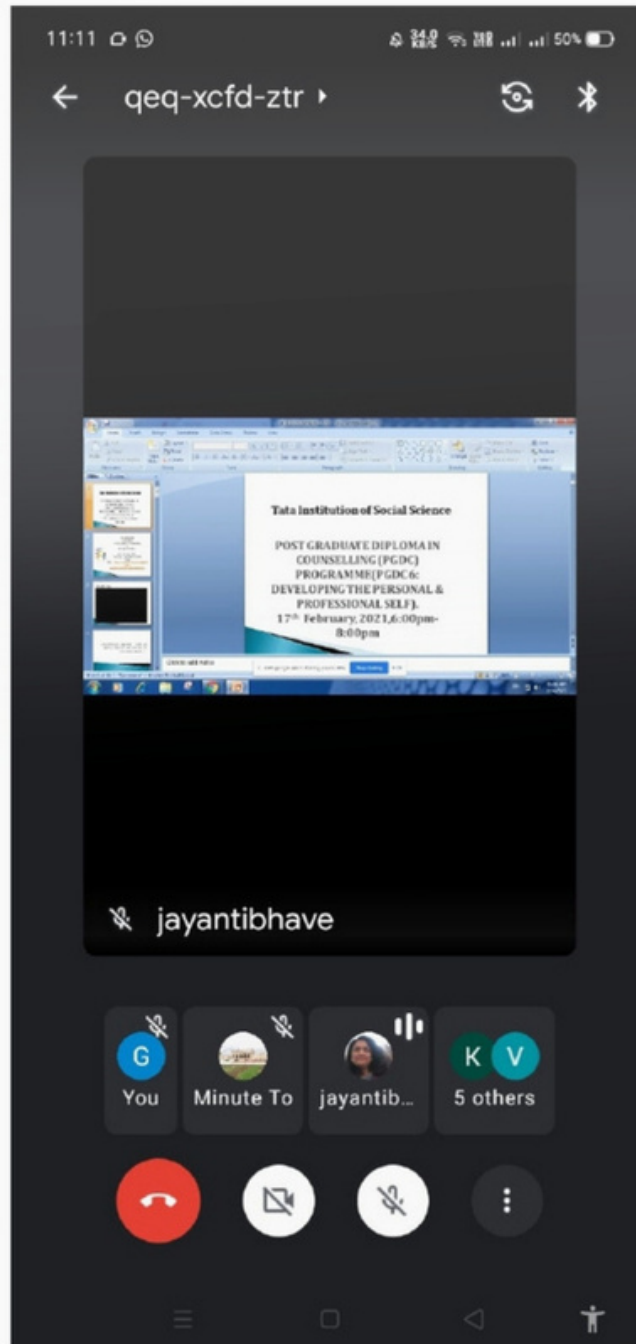


Online Lectures on Zoom meeting platform

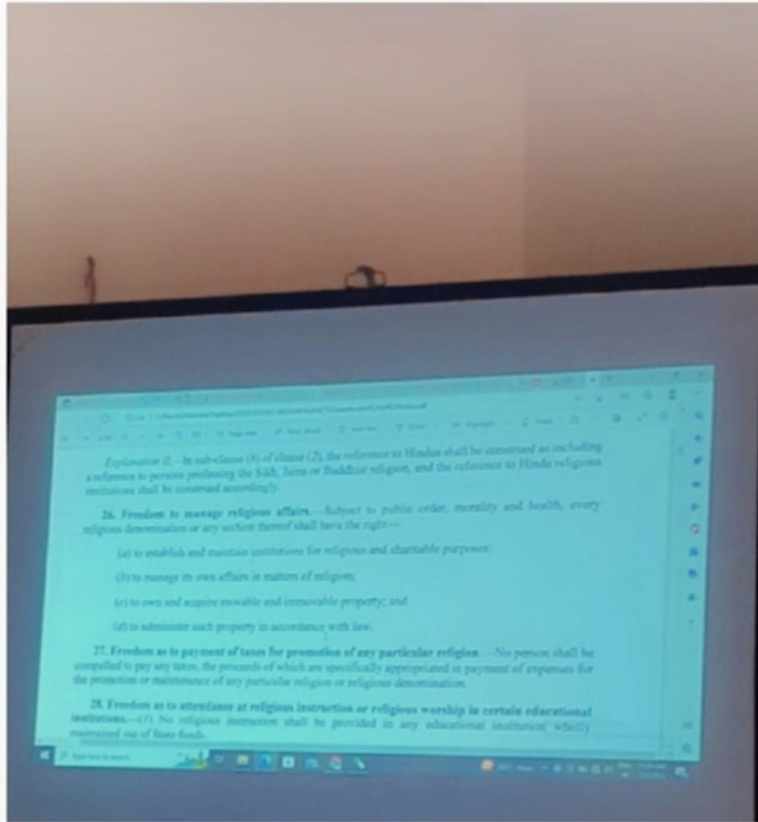

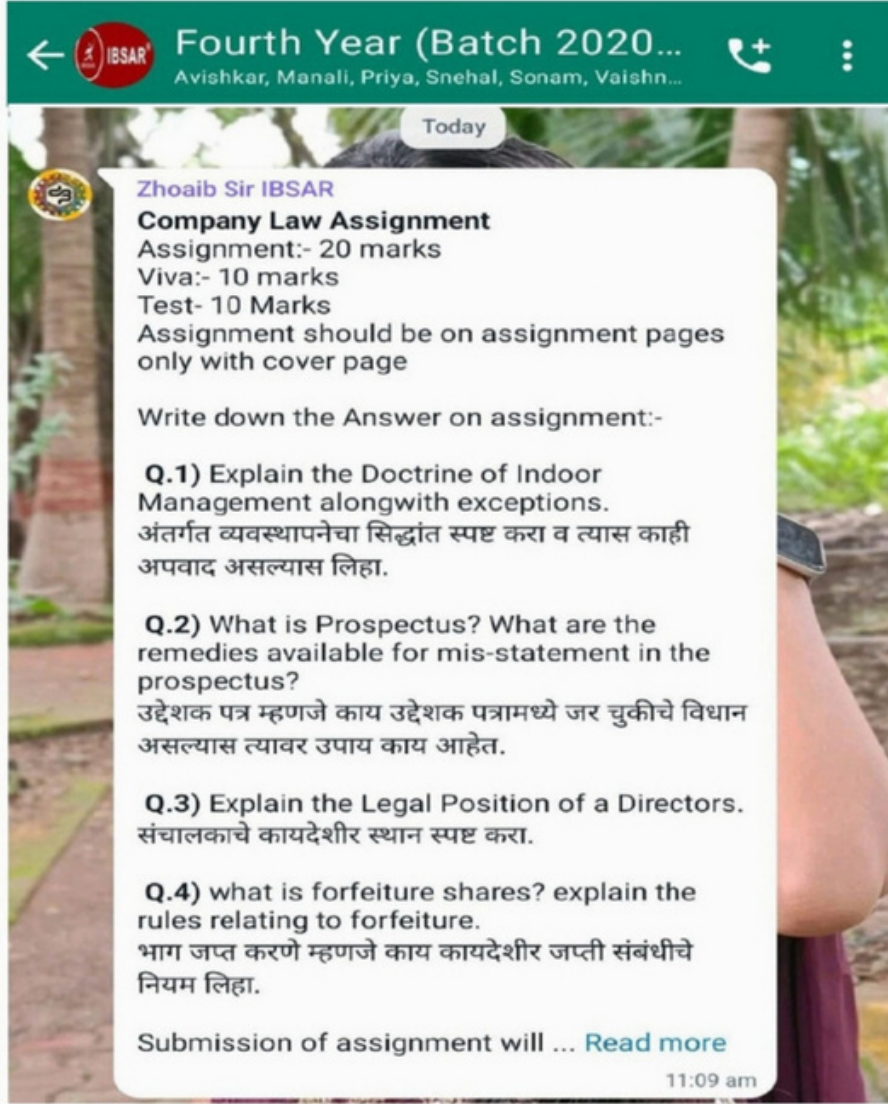
